## THUNDER PARK Terms and Conditions

You must agree to these terms and conditions. Please familiarise yourself with these before Using THUNDER Park as these apply to all people using the facilities.

1. In the absence of negligence or fraudulent misrepresentation committed by Thunder Park, their employees, officers, officials or agents, these Terms hereby exclude to the fullest extent permitted by law all responsibility and liability for the death, personal injury or illness of any person whilst present on the site.
2. Neither Thunder Park or its employees or agents shall be responsible for any loss, theft or damage to valuables or any personal property that belongs to any person whilst on Thunder Park premises.
3. Thunder Park reserves the right to refuse admission to any person on any grounds. Anyone who is visibly intoxicated or under the influence of drugs shall not be permitted to take part or on the premises.
4. **Helmets are compulsory for all riders on all ramps.**
5. **Folding scooters, V scooters, three wheeled plastic scooters or play equipment, stabilisers or geared bikes are not permitted.**
6. Under 16s MUST have consent of a parent or guardian. No entry to the park if a consent form has not been completed. There are no exceptions to this rule.
7. Children under the age of 12 must not be left unaccompanied on the premises.
8. We do not allow scooter pegs (exception to the rule for competitions). All bikes and scooters must have bar ends.
9. Buggies/pushchairs must not be taken into the park area under any circumstances.
10. Minimum standards of conduct apply including, but not limited to, controlling your speed, not behaving in a way that endangers or alarms others, using the equipment safely and respecting all signage.
11. Any abusive, dangerous, rude or anti-social behaviour will not be tolerated and may lead to the member/participant(s) being removed from the park and receiving a ban.
12. No throwing of objects, including helmets, skateboards etc in Thunder Park or anywhere in the building.
13. Thunder Park reserves the right to require you to leave the premises if you are deemed by a Thunder Park employee or officer not to be meeting reasonable standards of behaviour. In such cases, no refund will be given and a note placed on the members file.
14. No graffiti will be tolerated anywhere in the park.
15. In the interest of safety, beginners and those new to ramp riding should take time to familiarise themselves with the etiquette of the park before venturing into the main area.
16. We do not advise beginners and young children ride this park at peak times. Please see our website for information on coaching or contact a member of staff for advice.
17. If you observe a hazard or damage or are injured whilst using Thunder Park facilities you must bring this to the attention of an employee immediately. An accident report form must be completed and any injury to the participant should be notified and recorded therein, signed by the injured person or their representative and witness statements taken.
18. By signing and agreeing to our terms and conditions, you are declaring you are fit to participate and have declared any existing injuries and/or medical conditions.
19. All participants will adhere to safety rules in place and understand the risks involved (serious injury/death). By participating you agree to accept responsibility for your own actions and involvement.
20. Due to the age of the building it is likely that there may be damp patches and condensation that appears on the ramps. We will do our utmost to make sure these are maintained to the best of our ability and every rider should be aware of this.
21. The use of recording equipment and photography in the Thunder Park is prohibited unless prior permission is gained or granted. Thunder Park will monitor this footage and copyright is the property of Thunder Park solely. Users are advised this footage will be used for promotional and training purposes only.
22. School attendees should be aware that we will contact the appropriate authorities if we suspect anyone to be at the Park at a time we believe they should be in school.
23. Payment for use of Thunder Park will be made prior to participation. Anyone found to be in breach of this will be subject to asked to leave.

# Terms & Conditions Extended

24. No refunds will be made for "no show", late entry (other than that which has been caused by Thunder Park) or for leaving a session before the end. Exceptional circumstances may apply and will be at management discretion.
25. Any deception on the part of users of the skatepark will result in exclusion,
  
26. Thunder Park reserves the right to change its policies and terms and conditions from time to time. Please read and observe these policies and terms and conditions displayed in reception of Thunder Park before you use the park in case changes have been made.
27. Thunder Park operates a no smoking policy.

## DISCLAIMER

The risk of injury from the activities involved in Thunder Park is significant, including the potential for permanent disability and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist. All participants knowingly and freely assume such risks, both known and unknown, and assume full responsibility for their participation and for having and using the appropriate safety equipment. We do not accept any responsibility for other participant's failure to comply with these rules other than due to our negligence.

## DRUGS AND ALCOHOL DECLARATION

Thunder Park operates a zero tolerance Drugs & Alcohol Policy. Any person whether a participant or a spectator is found to be taking or dealing drugs or consuming alcohol will receive a life ban and possible further action. Anyone deemed intoxicated will not be allowed to enter the park.
